DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

ABATHOR Gel Bait is a slow acting insect gel bait. Control of an ant colony may take several weeks. Applying bait into or near the insect colony helps ensure insects contact bait.

ABATHOR Gel Bait is for use in controlling cockroaches and ants indoors and outdoors. Use suitable equipment capable of application into cracks and crevices, void spaces and other locations where insects may be harboring, living and breeding. Concentrate the bait placements as individual spots or a bead at insect activity sites.

USE RESTRICTIONS

Do not use on or contaminate fruit, vegetables or other food or feed crops.

Do not apply to humans, animals clothing or bedding.

Do not contaminate feed or food products or food preparation surfaces, dishes, kitchen utensils and food containers.

Cleaning residual bait with a damp cloth or sponge will help prevent staining.

APPLICATION RATES

ALL USES

For light infestations of Cockroaches, apply 4 - 6 bait points per 100 sq. ft. of treatment area. For heavy infestations of Cockroaches, apply 12 - 24 bait points per 100 sq. ft. of treatment area. Each bait point should equal about 0.25 to 0.50 grams of product. A spot approximately 3 mm or 1/8 inch in diameter equals 0.25 grams of product while a spot approximately 6 mm or 1/4 inch in diameter equals 0.50 grams of product.

FOR ANTS

Place several bait points as close as possible to the site of actual or suspected activity.

APPLICATION IN ALL AREAS EXCEPT FOOD/FEED HANDLING AREAS OF FOOD/FEED HANDING ESTABLISHMENTS

For treatment in residential and the non-food/non-feed areas of Institutional, warehousing and commercial establishments, place bait into cracks and crevices, holes, pipe chases, undersides of furniture, under drain plates, In or under trash containers, hidden surfaces around sinks and storage areas, behind baseboards, around doors and windows, inside, behind and under cabinets, drawers and shelving, under and behind appliances such as stoves and refrigerators and in attics and crawl spaces. Also apply in points between different elements of construction, between equipment and floors, openings leading to voids and hollow spaces in walls, equipment legs and bases and crawl spaces where insects hide. During follow-up visits, inspect bait placements and re-apply when necessary. Avoid depositing the product onto exposed surfaces. If gel contacts an exposed surface, remove gel and wash exposed surface.

APPLICATIONS IN FOOD/FEED AREAS OF FOOD/FEED HANDLING ESTABLISHMENTS

Food/feed handling establishments are defined as places other than private residences in which exposed food/feed is held, processed, prepared or served. This includes areas for receiving, storing, packing (canning, bottling, wrapping, boxing) food. Also included are areas of edible waste storage and enclosed processing systems (mills, dairies, edible oils, syrups) of food. Serving areas where food is exposed and the facility is in operation are also considered food areas.

Apply ABATHOR Gel Bait directly into cracks and crevices. Apply small amounts of gel (up to 0.50 gram) per point. Do not apply bait to areas where food utensils or food processing surfaces may become contaminated. Do not apply bait to areas that are routinely washed such as cracks and crevices in tops of tables, food/feed preparation and prepared food holding surfaces as bait may be removed by washing. Avoid depositing gel onto exposed surfaces. If gel contacts an exposed surface, remove gel and wash exposed surface. Food/feed areas include areas for receiving, storage, packing (canning, bottling, wrapping, boxing), preparing edible waste storage, and enclosed processing systems (mills, dairies, edible oils, syrups). Serving areas are also considered food/feed areas when food is exposed and facility is in operation. Apply bait in small amounts between different elements of construction, between equipment and floors, openings leading into voids and hollow spaces in floors, walls, ceilings, equipment legs and bases, around plumbing pipes, doors and windows, behind and under refrigerators, cabinets, sinks, closets, stoves and other equipment where cockroaches hide. A reapplication can be made during a follow up visit, if an inspection reveals it is needed. Application of this product in food/feed areas of food/feed handling establishments other than as a crack & crevice treatment is not permitted. Do not treat food preparation surfaces

APPLICATIONS IN AIRCRAFT

Do not apply within aircraft cabins or in cockpit area.

Application is limited to crack and crevice treatment only. Apply ABATHOR Gel Bait in suspected and infested areas. Use 12-24 bait placements per 100 sq. ft. Do not apply bait to areas where food utensils or food preparation surfaces may become contaminated. Do not apply bait to areas that are routinely washed, as bait may be removed by washing. Avoid depositing gel onto exposed surfaces. If gel contacts an exposed surface, remove gel and wash exposed surface. During followup visits, inspect bait placements and reapply when necessary.

OUTDOOR USE

Use for control of cockroaches. Inject into cracks and crevices around windows and doors, porches, screens, eaves, patios, garages, under stairways and in open crawl spaces and other areas where pests may be nesting or trailing, such as tree holes and cracks in fence.

STORAGE AND DISPOSAL

Do not puncture or incinerate. Do not contaminate water, food or feed by storage or disposal.

STORAGE: Store in a cool dry area away from heat or open flame and inaccessible to children.

PESTICIDE DISPOSAL: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

CONTAINER DISPOSAL:
