

DIRECTIONS FOR USE

Orkin Actizyme® Aerosol Foam is a convenient, ready-to-use foam containing premium, natural grime-eating, odor eliminating microbes and citrus oil. Shake well before using. Press down on the actuator to dispense foam. The product may be dispensed with the can in any orientation. Use in a well-ventilated area and avoid breathing spray mist. To coat scummy surfaces with foam, hold the can about 12" away from the surface and apply in a sweeping motion. To inject into drains, cracks or crevices, carefully insert the included straw into the actuator. For deep injection into drains or hard to reach spots, use the 24" tube extension black actuator supplied in the case. Carefully remove the standard actuator from the can and press the black actuator tube extension onto the can and dispense as needed. Insert the tube in the drain or other desired area and dispense foam in cracks, crevices, drains and surfaces where organic build-up has occurred. Remember that organic build-up does not just occur in drains, but can happen in any area where food, moisture or other organic matter is present. Prime areas include peeling baseboards, machinery cracks, beverage line bundles, beverage fountain drip trays, under ice machines and voids around dishwashers, walk-in coolers and tray conveyors. The foam will take a few hours to dissipate and should be left and not washed up. The foam will need to be in contact with the organic build-up for a period of time (at least two hours is ideal) to be most effective. Do not apply directly to food contact surfaces unless the surface is treated with a quaternary ammonia type disinfectant, or steam-disinfected, after treatment. Precautions: Keep out of reach of children. If any amount is swallowed, seek medical attention immediately. Give one glass of water and do not induce vomiting. Wash hands well after use. Store out of reach of children, between 35 and 95 °F.

HOUSEHOLD CLEANING USES

Carpet

Orkin Actizyme® Aerosol Foam can be used to clean a variety of stains on carpet. Orkin Actizyme® is best applied immediately after a spill while the stain is still wet. If applied later, lightly spray over the stain with water to moisten the area to be cleaned. Multiple applications of Orkin Actizyme® Aerosol Foam may be necessary for very dark stains, or old stains. Orkin Actizyme® Aerosol Foam should be allowed to completely dissipate on the stain.

Do not scrub or wash after application.

Simply spray over the stain, completely covering it with foam and allow the microbes to work undisturbed. This product works well on soda, juice, milk, wine, beer, food residue, oil, urine, vomit, and most other organic matter. Always test Orkin Actizyme® on a small area of any fabrics first to be sure it will not stain.

Other Areas

Orkin Actizyme® Aerosol Foam can be used to control a variety of household odors. Smelly drains, garbage disposals, litter boxes, and trash cans are all ideal areas to be cleaned using Orkin Actizyme®. In the case of drains and trash cans simply spray Orkin Actizyme® Aerosol Foam into the receptacle and allow it to dissipate. For litter boxes spray Orkin Actizyme® into the box and pour a normal amount of litter directly on top of the foam. Other grimy or smelly surfaces may also be treated with Orkin Actizyme®. Avoid treating direct food contact surfaces, and always test Orkin Actizyme® on a small area of any fabrics first to be sure it will not stain.
