GENERAL: BOND MAX® combines the adherence ability of a latex polymer with super coverage of non-ionic surfactants. BOND MAX will increase deposition, reduce run-off and secure spray from rain or overhead irrigation. BOND MAX will decrease surface tension, resulting in better coverage. BOND MAX promotes rapid spreading for a uniform protective film.

DIRECTIONS FOR USE: Fill spray tank 1/2 full with water and begin agitation. Add pesticides as directed by label, while maintaining agitation. After pesticides are thoroughly mixed, eliminate any existing foam with approved defoamer (Unfoamer®), and then fill tank to desired water volume before adding BOND MAX. For tank mix compatibility concerns, conduct a jar test of the proposed mixture to ensure compatibility of all components. Mix components in the same ratio as the proposed tank mix.
