DIRECTIONS FOR USE:

Breaker LF should be applied at the rates listed below, if the pesticide label does not have a specific recommendation for surfactant use and does not prohibit the use of nonionic surfactant. Observation of performance in a trial application is recommended to determine efficient surfactant rates.

FOR LIQUID FERTILIZATION AND AS A SPRAY ADJUVANT WITH INSECTICIDES/MITICIDES/TERMITICIDES AND FUNGICIDES:

Apply Breaker LF at a rate of 6-13 ounces per 100 gallons of spray solution.

MIXING INSTRUCTIONS

1. Fill tank to 2/3 to 3/4 full of water. Breaker LF contains an anti foaming agent so foaming should be minimal but if other ingredients cause excessive foaming it may be necessary to add more anti foam.
2. Add pesticide as directed by pesticide label.
3. Continue agitation.
4. Add Breaker LF and continue filling tank while maintaining agitation.
