**EASY APPLICATION INSTRUCTIONS**

**APPLY USING A ROTARY SPREADER - RECOMMENDED SPREADER SETTING IS 60%.**

**4 EASY STEPS TO APPLY** 1. Remove existing feces and urine along with affected dirt, soil and mulch. prior to applying. **VERY IMPORTANT** Removing helps eliminate their markings. 2. Before applying, turn bag upside down and shake closed bag vigorously. 3. Apply by spreading granules in and around the area to be protected. The product should repel cats immediately and quickly train them to avoid treated areas. If necessary, reapply as needed until avoidance is demonstrated. 4. Once repelling action is well established, reapply ever 2 - 3 weeks.

**FOR LAWN AND GARDEN AREAS OF 11,000 OR LESS SQUARE FEET**, we recommend covering the entire area.

**REAPPLY** Use every 2 to 3 weeks depending on weather. May have to reapply after heavy rainfalls.

**ALL SEASON USE** Each application of Cat Repellent should last 30 days including normal rainfall or irrigation.

**DO NOT USE** on food or feed crops. Do not apply directly to water.
