POST EMERGENT TREATMENTS

Cheetah may be applied post-emergence to crops containing the Glufosinate-resistant gene including Glufosinate-resistant canola, corn, cotton, soybean and sugar beets. Uniform, thorough spray coverage is necessary to achieve consistent weed control.

The basis of selectivity of Cheetah herbicide in glufosinate-resistant crops is the presence of a gene that makes crops not sensitive to glufosinate. Crops not containing the glufosinate-resistant gene will be sensitive to Cheetah and severe crop injury and/or death may occur. DO NOT allow spray to contact foliage or green tissue of desirable vegetation other than crops containing the glufosinate-resistant trait.

Post emergent applications of Cheetah may be applied to crops not containing the glufosinate-resistant gene using a hooded sprayer.
