GENERAL INFORMATION: *CrossOver G Turf* is a granular soil product for turfgrasses with calcium and magnesium deficiencies. It will also aid turfgrass soils with chemical imbalances, structural instability and ion toxicity issues associated with salt affected and high pH sodic soils. Available in 100 SGN and 200/300 SGN sizes.

DIRECTIONS FOR USE: Proper application rates and frequency should be determined by specific conditions and plant requirements. A soil analysis is recommended prior to application of *CrossOver G Turf*. Apply *CrossOver G Turf* during periods of high calcium demand such as cell division and initiation of root growth. Apply at 5-10 lbs. per 1000 sq. ft. per month during a 3-month treatment period to build sufficient calcium and silicon reserves in the soil. *CrossOver G Turf* can also be applied as a single treatment at 25-30 lbs. per 1000 sq. ft. Application guidelines: When applying CrossOver to WET turf, water in immediately
When applying CrossOver to DRY turf, water in same day irrigation cycle

Do not allow the product to partially hydrate without completely watering into the soil. Total water requirement is 1/2" of water even if rainfall is anticipated.

For all turf uses, do not apply near water, storm drains, or drainage ditches. Do not apply if heavy rain is expected. Apply this product only to turf, and sweep any product that lands on the driveway, sidewalk, or street back onto the turf.
