3. COMPOSITION/INFORMATION ON INGREDIENTS

Product is not a "substance" or a "preparation" under the CHIP 3 Regulations enacting the Dangerous Preparations Directive. Product is an insect trapping device in the form of a glue board. The board is placed in the base of a small plastic contraption, which is assembled into a tent-like form for placement at the insect infestation site.

Directions fo Use

- Do not smoke or eat prior to handling.
- Wash hands before and after handling.
- Place Demi-Diamond stations as to not come in contact with children or pets.
- Peel off and discard the contact paper from the Demi-Diamond glue board.
- Insert the glue board into the assembled Demi-Diamond station (do not to touch the glue).
- Do not use near, or around, insecticide treated areas.
- Glue boards work best within low air movement environments.
- Place Demi-Diamond stations near observed Fruit fly activity (deploy multiple stations in a grid pattern and document on a trap-line audit form).
- Add target pest lure to the 30 ml reservoir (at the bottom of station).
- Maintain Demi-Diamond stations year-round for census monitoring.
- Label, address, number, or placard Demi-Diamond(s) in the section provided.
- Replace the glue board every 2 to 4 weeks (or when covered or dusty).
- Store glue boards in a dry, well ventilated, and cool space.
