EcoVia G should be used for outdoor applications and may also be applied to the soil in interior plantscapes. Apply using a hand-operated or power spreader or duster, shaker container or other standard granule application equipment at a rate of 1-2 lbs per 1000 sq ft. EcoVia G granules do not need

 $\textbf{Exterior Perimeter Treatment:} \ Apply in a uniform band at a rate of 1 to 2 lbs per 1000 sq ft in an area 2 to 5 feet around the foundation, including all landscaping, under bushes and shrubs, under the landscaping of the landscaping of the landscape of th$ overhanging decks, and other areas adjacent to structure.
