Equipment: Handheld sprayer, backpack sprayer, high pressure sprayer, ULV handheld or backpack fogger.

(Do not use thermal foggers as this will impede effectiveness).

Protocols: Follow I.P.M. (Integrated Pest Management) inspection standards. Perform inspections to locate pathways, nests, food & water resources, and dark spaces. Remove all attractants, if possible, and declutter areas of infestation. **Interior:** Remove or cover items you do not want product to contact. Begin treatment on the interior first by spraying or fogging pathways and areas where targeted pests are active. Focus on the dark spaces under or behind appliances, pantry, sinks, plumbing penetrations, along thresholds, other cracks & crevices, and voids. Fog attics and crawlspaces, especially along travel points around studs, rafters, piers, conduit, ledges, and purlins. **Exterior:** Spray or fog diluted formula, until wet, around perimeter of structure. Spray the walls and vertical pathways 3-6 feet high, and along foundation 1 foot from structure, and into weep holes, if present. Vertical pathways are, but not limited to, downspouts, pipes, posts, conduit, overhanging trees, power pole supply to structure. *(Avoid contacting electrically charged wires or other electrical items).* Spray the ground 3 feet around trees and poles that are pathways. Spray foliage, inside, outside, and under trash cans, and dumpsters. **Burrows:** Spray into burrows after applying Exodus Granules inside burrows, and cover openings with soil or rock.
