Ornamentals: apply 1-2 quarts per 100 gallons of water and spray to runoff as needed Commercial Sod: apply 1-3 gallons per acre to green up turf as needed or before harvest

Use sufficient water for thorough and uniform coverage of foliage or soil. Always make a bench test to check compatibility of unknown mixes. Avoid tank mixing with heavy-phosphate fertilizers or alkaline products. Apply in early morning or late evening, avoid excessive heat or dry conditions.
