### GENERAL INFORMATION

Gravity S MicroGuard is a 100% soluble fertilizer designed to provide an enhanced color, greening response in turf and ornamentals. Gravity S MicroGuard is specifically formulated to be root absorbed by plants. The EDTA chelation reduces the binding of nutrients by the soil, thus increasing plant availability and longevity of the micronutrients.

A number of variables influence the rate of application necessary to prevent or correct a specific deficiency. For best results, follow good agronomic practices and conduct soil, resin or tissue test. Additional fertility may need to be supplied from other sources. For specific recommendations for your plants, consult your local Heritage Professional Products representative.

### DIRECTIONS FOR USE

Exercise care when applying product. May be harmful if swallowed or inhaled. Keep out of children's reach. Avoid eye contact and prolonged, repeated contact with skin. May cause eye, membrane, and skin irritation. Wash all contact areas thoroughly after handling.

### READ ENTIRE LABEL BEFORE USING

Gravity S MicroGuard can be tank mixed and will be compatible with most products. **Do not apply with calcium or phosphates in large quantities.** If you are unfamiliar with the product, a jar test should be used to confirm compatibility and a small area should be treated with the product prior to large scale application.

### WARNING:

- Over-application or excessive use of boron or use on plants other than those listed as having a boron response, can result in boron toxicity and may cause serious crop injury.
- Molybdenum can be toxic to plants. Make sure your soil indicates the need for additional molybdenum prior to seed treatment or fertilizer use. The application of fertilizing materials containing molybdenum (Mo) may result in forage crops containing levels of molybdenum (Mo) which are toxic to ruminant animals.

### GOLF COURSES

Gravity S MicroGuard should be applied at 0.5 to 3 lbs per acre. every 21 to 31 days as needed during the growing season. Spray volumes can range from 1 to 4 gallons per 1,000 sq. ft. for adequate coverage. Gravity S MicroGuard may be used on greens, tees, fairways, roughs, and other turf areas composed of turfgrasses. For best results do not irrigate or mow until sprayed area has completely dried.

### LAWNS AND OTHER TURF AREAS

Gravity S MicroGuard should be applied at 0.25 to 4 lbs per acre every 21 to 31 days as needed during the growing season. Spray volumes can range from 0.5 to 4 gallons per 1,000 sq. ft. for adequate coverage. Gravity S MicroGuard may be used on all turfgrasses. For best results do not irrigate or mow until sprayed area has completely dried.

### TREES AND ORNAMENTALS

Gravity S MicroGuard should be applied at 0.25 to 4 lbs per acre of landscaped area every 21 to 31 days as needed during the growing season. For container grown products, trees or other ornamentals apply a foliar spray or soil drench at a rate of 1 to 10 lbs. per 100 gals of water. In a drench, use a minimum of 5 gallons of carrier. Prior testing is required before applying to open flowers.

Agitation will aid in getting the product to go into solution. If carrier water is cold, user may need to pre-mix the soluble fertilizer with warmer water in a separate container prior to adding it into the sprayer.

### **Spray coverage and drift control:**

To optimize spray coverage or deposition, and to reduce drift, include Droplex® adjuvant.
