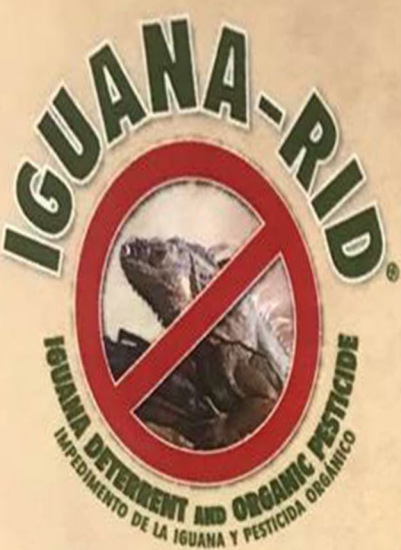

Iguana-Rid® is non-harmful, and works by producing an odor and taste which is disagreeable to iguanas. Initially applying liberal amounts will be most effective. It may take several days for results depending on the severity of the infestation. Re-application is recommended every 3-5 weeks.
