### GENERAL INFORMATION

**IMPROVE** is a concentrated, high-quality surfactant blend that provides top performance in research and normal use. **IMPROVE** is excellent at wetting and plant absorption, enhancing the performance of herbicides and pesticides. **IMPROVE** contains proprietary humectants that keep the spray deposit moist longer, allowing for extended uptake and rewetting. **IMPROVE** also includes a unique and very effective defoaming system. **IMPROVE** does not contain isopropyl alcohol or fatty acids as "active ingredients" as many surfactant products do.

### DIRECTIONS

1. Always follow pesticide label directions for mixing and use rate directions. When mixing with emulsifiable products, add **IMPROVE** after the emulsion forms.
2. Shake well before each use.
3. For herbicides, use 0.5 to 2 qt/100 gal in most situations. Use 2 or even 3 qt/100 gal under stress conditions when weeds have thick cuticles and are difficult to control.
4. For insecticides and fungicides, use 2 to 8 oz/100 gal in most situations.
5. Turf and hydrophobic soils can benefit from **IMPROVE** by allowing water to infiltrate the soil, usually 2 to 8 oz/1000 sq ft initially and then a half rate monthly.
6. In irrigation injection systems, use 2 to 16 oz/1000 sq ft.
7. **IMPROVE** may be used in aquatic applications at labeled rates.
