DIRECTIONS FOR USE

Lesco 90/10 Nonionic Surfactant is a high flash nonionic general purpose spray adjuvant for use on plants to improve the effectiveness of insecticides, herbicides, fungicides, and defoliant by providing more uniform coverage without excessive run-off of the spray to increase contact activity and to aid in penetration, allowing the use of lower labeled pesticide rates. Lesco 90/10 Nonionic Surfactant contains a large percentage of crop-based components, to enhance biodegradability and decrease the amount of undesirable chemicals in the environment.

DUST CONTROL

Use Lesco 90/10 Nonionic Surfactant for temporary control of nuisance dust on unimproved roads, construction zones, etc. Add 2 quarts per 100 gallons of water.

HERBICIDES

Unless otherwise directed by manufacturer of herbicides, use 1 to 3 pints of Lesco 90/10 Nonionic Surfactant per 100 gallons of spray for post-emergence use of products such as Image®, Basagran®, phenoxy herbicides (1 to 3 teaspoons per 1 gallon) (i.e., Three-Way Selective™), Methanearsonates (i.e., MSMA 6.6) Poast®, Fusilade®, etc.

SOIL PENETRANT

Add with suitable quantities of water, 8 ounces of Lesco 90/10 Nonionic Surfactant to 1,000 sq. feet of lawn area. Always add Lesco 90/10 Nonionic Surfactant to the spray tank as the last ingredient with the agitator running (1/2 teaspoon to three gallons of water).

DEFOLIANTS

(Use magnesium and sodium chlorate and with chlorate/borate defoliant and herbicides.)

Use 1 quart per each 100 gallons of dilute spray when spray application is at the rate of 10 gallons per acre.

Use 2 quarts per 100 gallons of spray when application is at 5 gallons per acre.

Use 2 quarts per 100 gallons of airplane spray application.

INSECTICIDES, FUNGICIDES, ACARICIDES

Lesco 90/10 Nonionic Surfactant may also be used to enhance the wetting characteristics of the above pesticides at a rate of 2 ounces to 8 ounces per 100 gallons of spray mix. The actual rate will vary depending upon plant size and type of foliage to be covered.
