TURFGRASS SPRAY APPLICATION: LESCO MacroN™ Fertilizers are best applied to actively growing turf. Avoid spraying in periods of low humidity or when the turf is under severe stress. Apply as needed to maintain turf color and growth. Actual rates will vary upon management practices, turf species, and time of the year.

Apply LESCO MacroN Fertilizers in 2 to 6 gallons of water per 1,000 square feet. Use a sprayer with a boom, floodjet, handgun or similar spray application device. Calibrate the sprayer prior to use to determine the spray application rate.

LESCO MacroN Fertilizers are compatible with many pesticides and other fertilizer formulations. When working with new or unfamiliar products it is suggested that a small quantity be jar mixed to check for incompatibilities prior to tank mixing.

Mixing Instructions: Add one-half water to tank. Add LESCO MacroN Fertilizer and any other fertilizers. Agitate tank contents while adding the remaining water. Finally add pesticides if included in the tank mix. Use spray tank mixes as soon as possible.

For additional turf color response add LESCO Chelated Iron Plus or LESCO Chelated Micro Mix to LESCO MacroN Fertilizers.

ORNAMENTAL FOLIAR APPLICATION: LESCO MacroN Fertilizers are particularly valuable for supplementing other types of fertilization or for promoting growth during adverse soil, moisture or temperature conditions when other means would be ineffective or uneconomical.

Apply LESCO MacroN Fertilizers to foliage with sufficient spray to thoroughly wet the foliage. Follow the table below for mixing rates. For tender plants use half strength spray solutions. Avoid spraying in periods of low humidity or when plants are under severe moisture stress. Use a sprayer with a handgun, spray wand, or similar spray application device. Apply as needed during the growing season to maintain plant growth.

ORNAMENTAL SOIL DRENCH: Apply LESCO MacroN Fertilizer as a soil nutrient drench around the base of newly transplanted and established plants. Use the foliar mixing guide for suggested rates. Apply up to 1/2 gallon of nutrient solution per square foot of surface area with a watering can or similar device. Apply as needed to maintain plant growth throughout the growing season.

DEEP ROOT INJECTION: Apply LESCO MacroN Fertilizer by deep root injecting the soil uniformly under the tree canopy area with 2 to 5 gallons of nutrient solution per inch of trunk diameter. Use 2 to 5 pounds of LESCO MacroN Fertilizer per 100 gallons of water. Apply in the Spring and the Fall as needed to maintain plant growth. For additional fertilizer response use LESCO ArborGreen® and LESCO Chelated Micro Mix.

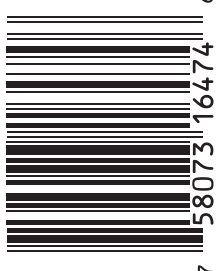
