This product has an odorless bait that roaches eat even in the presence of other foods and is packaged in a child-resistant bait station. The transparent red top enables you to monitor bait consumption while providing roaches their preferred environment, darkness, because roaches do not see light in the red spectrum. Do not allow children or pets to play with bait stations.

1. Place MAXFORCE Roach Killer Small Bait Stations in areas where cockroaches have been seen

- and where they hide. Cockroaches infest dark, warm, damp locations.
- 2. The bait stations can be stuck to a vertical surface by peeling off the bottom label to expose adhesive.
- 3. For effective roach control use 4-6 bait stations per 100 sq ft of horizontal surface area. Place adjacent to walls and flush in corners.
- 4. Do not spray the bait stations. Avoid placing the bait stations on freshly sprayed surfaces.
- 5. Roaches will begin eating the bait immediately and you should expect to see fewer roaches within two weeks.
- 6. Inspect all bait stations and replace as needed for continual control of roaches.
