where possible). Advice for Medical Doctors: Difenacoum is an indirect anti-coagulant. Phytomenadione, Vitamin K, is antidotal. Determin prothrombin time not less than 18 hours after consumption. If elevated, administer Vitamin K1 until prothrombin time normalises. Continue determination of prothrombin time for two weeks after withdrawal of antidote and

resume treatment if elevation occurs in that time.

Inhalation Due to the physical nature of this product, exposure by this route is unlikely. IF INHALED:

Move affected person to fresh air and keep warm and at rest in a position comfortable for

breathing. Get medical attention if symptoms are severe or persist.

Ingestion Rinse mouth thoroughly with water. Do not induce vomiting. Get medical attention

immediately.
