**IF IN EYES:** Immediately flush eyes thoroughly with large quantities of water for 20 minutes while holding the eye lids open to ensure the material is washed out. Remove contact lenses if present and easy to do. Get immediate medical attention.

**IF ON SKIN or CLOTHING:** Remove contaminated clothing. Wash contact area thoroughly with soap and water for several minutes. Launder clothing before re-use. Get medical attention if irritation or rash occurs.

**IF SWALLOWED:** Do not induce vomiting unless told to do so by medical personnel. Keep the victim calm and warm. Get medical attention if symptoms develop.

**IF INHALED:** Remove to fresh air. If breathing is difficult or irritation persists, get medical attention.

**PHYSICAL AND CHEMICAL HAZARDS:** Do not apply on or around electrical wiring. Do not apply to hot surfaces or equipment.

**STORAGE AND DISPOSAL:** Do not contaminate water, food, or feed by storage or disposal. Store in original container at room temperature in a dry location inaccessible to children or animals. Do not reuse container. Rinse empty container and recycle or dispose in trash. Comply with state and local guidelines for disposal of unused product. Keep containers closed when not in use.

### Directions for Use

For best results, before the application, turn off all evacuation and cooling fans of the area to be treated and leave the fans off until the powder has settled (can take up to 15 minutes). Wait until the product has settled to return to the site.

Operate blower on high delivery setting (e.g. a setting of 5-6 for a Stihl backpack blower) and IDLE speed.

### Application for Bed Bugs

P3 can be applied to control bed bugs while birds are present. Before treatment, turn off fans and leave off until the product has settled (about 15 minutes after application). Wait until the product has settled from the air to return to the area.

Apply at a rate of 20-30 lbs. of P3 per 100 feet of the facility. Make sure to apply to potential harborage areas, including gaps along walls, behind sheeting or framing, attics, around drop ceiling joints and above drop ceilings, gaps between walls, and nest areas, work rooms and equipment.

Repeat application of P3 every 4-6 weeks or reapply as needed for bed bug control.

### Application for Northern Fowl Mites

#### For layers:

Apply at a rate of 4-6 lbs of P3 per 1000 sq. ft. of facility. Apply when birds are 25-26 weeks old; one week after first application, make a second application. Blow dust on birds and cages in each level of every row, ruffling feathers to penetrate.

#### For broilers/breeders:

Apply at a rate of 20-30 lb per 100 feet of application area, operating blower on high delivery setting (e.g. a setting of 5-6 for a Stihl backpack blower) and IDLE speed. Blow P3 into both sides of nest boxes and into scratch area.

Repeat application every 6-8 weeks in case of high infestation rate and every 3 months for maintenance, or as needed for mite control.

As part of a preventative program, after cleanout and washing of house, apply P3 into harborage areas such as nesting boxes, scratch areas, and attics at a rate of 4-6 lbs per 1000 sq. ft. of facility.
