HOW IT WORKS

The natural anionic surfactant and detergent properties of SNS PC™ disrupt the insect cell structure and respiratory membranes causing the insect to dehydrate, suffocate, and die. DIRECTIONS FOR MIXING

SHAKE WELL BEFORE MIXING

Mix 6-14 fl oz (12 to 28 tablespoons, 177 ml to 420 ml) per gallon. Solution may be used immediately or can be stored for up to 1 week prior to use.

SHAKE WELL BEFORE USE

Foliar Spray - Plant Site Use For All Plants (Leaves "Foliage," Stems, Stalk, Fruit and around Flowers), **Coverage** = 1 gallon of mixed solution will cover approximately 550 square feet. No restricted entry interval (REI)=0 days.

Depending upon severity of infestation several applications may be required. If needed spray every 3-5 days until you have control of the problem. Complete coverage of all plant tissue or surface area is necessary for control. Make sure to spray under the leaves and in corners where spiders and other insects as listed hide and lay their eggs. To reduce the chance of burning do not use under direct sunlight or grow lamps. Use on a 7-14 day schedule as preventative maintenance.
