Rats*: Apply 4 to 16 of the one-ounce. Ramik Mini Bars per placement. Space placements at intervals of 15 to 30 feet in infested areas. Maintain an uninterrupted supply of fresh bait for at least 10 days or until there no longer are signs of new feeding by rats.

When bailing sewers, securely attach one end of a wire to each lock and the other end to a stationary structure, such as the bottom step of a manhole ladder or a sewer grate. Allow just enough wire for the block to test on the manhole benching.
