Provides a long-term repelling barrier against rodents plus kills insects & arachnids on contact, while providing an effective repelling barrier. Rodent Application: When treating for rodents it is imperative to follow protocols very carefully to insure adequate coverage is acquired for optimum results. **Mixture Rate:** 6 ounces per gallon or 178 milliliters per 3.79 Liters. **Protocol:** Follow I.P.M. (Integrated Pest Management) inspection standards for rodent control. Perform inspections to locate rodent pathways, nests, food & water sources. Remove all attractants as much as possible, declutter and clean areas of infestation. Apply diluted mixture with pump up sprayer or ultra-low volume fogger in all areas where rodents exist. **Interior:** Remove or cover items you do not wish product to contact. Begin treatment on the interior first by spraying or fogging along baseboards, inside cabinets, pantries, behind and under appliances, along thresholds and plumbing penetrations and other cracks, crevices and voids. Fog attics and crawlspaces, especially along travel points around walls and on rafters. *Follow up this treatment by dusting with Ratsect Pro Rodent & Insect Dust in the attic, crawlspaces, plumbing entries, thresholds, cracks, crevices and voids. Place Ratsect Pro Rodent & Insect Pouches inside cabinets, pantries, closets, wherever rodents exist.* Do not perform exclusion work until **AFTER** Ratsect Pro application has been in place for at least 48 hours, to allow rodents the opportunity to vacate premise. Place glue-boards in key locations to help trap any remaining rodents, if desired. **Exterior:** Spray or fog diluted formula, until wet, around parameter of structure along foundation and soil line plus up the wall waist high. This process interrupts the rodent's pheromone trails causing confusion and irritation to rodent as well. Treat all vertical areas, waist high, such as downspouts, pipes, posts, or any other item where rodents may climb and gain access. Remove any branches that are on or near structure or roof and spray base of tree trunk waist high to repel from climbing and gaining access to structure. Spray any foliage near walls as well. If any burrows are discovered spray inside of burrow and then fill burrow opening, until full, with Ratsect Pro Rodent & Insect Pellets. Once Ratsect Pro products have been in use 48 hours perform inspection to see if there are any further signs of infestation. If so, re-treat areas where rodents are observed and perform exclusion work once no signs of infestation exist. Follow up treatments should be every 4-6 weeks depending on attractants and infestation issues.

Insect Application: Follow similar protocols as rodent application. If rodents are not present and treating for insect pest dilute concentrate at 4-6 ounces per gallon water, or 118-178 milliliters per 3.79 Liters, depending on pest species. Dusting for insects only, no rodents, perform application once per year. See Ratsect Pro Rodent & Insect Dust label for details. Ratsect Pro Rodent & Insect Pouches will extend the effectiveness of application. Retreat every 30 or 60 days, or as needed.

Precautions: KEEP OUT OF REACH OF CHILDREN. Avoid contact with eyes to prevent irritation. Wear safety goggles while mixing or applying product. If contact occurs, flush with clean water or saline solution for 15 minutes. Avoid contact with skin, wear gloves and protective clothing. If contact occurs wash with soap and water. Avoid inhalation, wear face mask. If inhaled move to fresh air. Do not ingest product. If ingestion occurs induce vomiting. In all cases if irritation occurs or you have contact concerns contact a physician. Spot check fabrics for discoloration prior to application.

Storage & Disposal: Do not contaminate water, food, or feed by storage or disposal. Store in original, tightly sealed container. Keep in cool dry place away from direct sunlight, excessive heat or freezing. Storage temperatures range from 33°-110°F or .56°-44°C. Do not reuse container.
