



**PRECAUTIONARY STATEMENTS**

**First Aid**

**Shake Well Before Using**

**To Kill and Control Adult Mosquitos and Kill Ticks Effectively Kills Mosquitoes and Ticks in 24 hours or less.**

**For Outdoor Fogging and Misting Spray Applications:** Change the sprayer head to a fogging/misting head. Shake the product well. Mix 6 ounces of this product with 1 gallon of water, shake well to thoroughly mix, and continuously agitate spray mixture during application. Mix 12-16 ounces of this product with 1 gallon of water for heavy pest pressure. Do not use any other dilution rates. One gallon of mixture covers 3000-7500 square feet, depending upon vegetative density in the treatment area. For mosquito control, reapply every 3 weeks (21 days), or as reinfestations warrant. For ticks, reapply as reinfestations warrant. For best results, spray under shrubs, wood piles, leafy areas and anywhere that is shaded and moist. Spray into trees, including up and under the leaves, where adult mosquitoes and ticks hide during the day. Treat harborage areas such as shrubbery and vegetation where mosquitoes/ticks may rest. Shrubbery and vegetation around stagnant pools, marshy areas, pools and shorelines may be treated. Do not spray directly on ponds of all kinds, lakes, rivers or other bodies of water. May also be sprayed on, and will not discolor, swing sets, patios, eaves, windows, doorways, porches, porch lights and around utility boxes. May also be applied using hand-held, hose-end or backpack-type sprayers by following dilution directions above and sprayer manufacturer directions.

Do not allow anyone to enter treated areas until spray has dried. Do not spray on food-bearing plants/trees or on food contact surfaces. Avoid unnecessary release into the environment.

**For Use in Outdoor Automatic Misting Systems to Kill Mosquitoes within 24 Hours:**

Shake concentrate, then dilute in tank at the rate of 96 fl oz/55 gals of water (1.75 fl oz/gal of water). Set the flow rate to 1.4 fl oz/minute (40 ml/minute) per nozzle. Agitate mixture prior to misting. Follow system manufacturer's instructions for automatic settings and system maintenance. Do not spray this product when people, pets and food are present. Allow mist to dissipate before occupying the treatment area.

**Storage and Disposal**

Do not contaminate water, food or feed by storage or disposal.

**Storage:** Keep container closed when not in use. Store locked up in a cool, dry place away from direct sunlight, extremely high or low temperatures and incompatible materials (strong acids, bases and oxidizers). **Disposal:** Non-refillable container; do not reuse or refill this container. Place in trash or offer for recycling, if available. Dispose of contents/container in accordance with local regulations.
