**General Ecological Information:** Environmental: If released to the atmosphere, urea will degrade rapidly in the vapor-phase by reaction with photochemically produced hydroxyl radicals (half-life of 9.6 hr). 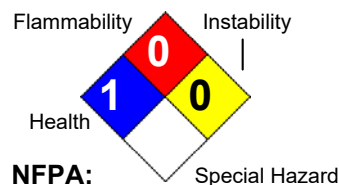
