Directions:

Truck Tanks: Fill tank with water first then add product to avoid foaming. 36oz makes 300 gallons/12 oz per 100 gallons. Use no more than 100psi to avoid drift. See section below for further instructions.

Mist Blower/3 Gal. Backpack Sprayers: For a 1st time application add 1oz per gallon of water. Maintenance 1oz per 3 gallons. Mix well. We recommend spraying all grassy areas, under shrubs, wood piles, leafy areas and anywhere on the property where it is shaded. Can also be sprayed directly on swing sets and patios. Apply every 21-30 days for ticks. Spray as often as needed for other insects and heavily infested areas.

Do not dilute more than recommended. You can use more product per gallon for heavily infested areas. This will lower your total gallon production. This 36oz container will produce 108 gallons of ready to use at the 1oz per/3gallon rate. Allow a minimal of 1 hour for drying time. Do not spray into any body of water. Toxic to aquatic life. Dispose empty container according to your states requirements for non-hazardous material. Store in cool, dry location away from sunlight. Do not spray around active honeybee hives.
