## DIRECTIONS FOR DRAIN CLEANING AND ODOR REDUCTION/ELIMINATION

---

Wash hands thoroughly after handling.

### DRAINS

**Clean-out:** Apply 4 to 8 fluid ounces per drain. Repeat as necessary. For faster results, flush with 2 to 4 gallons of water.

**Maintenance:** Apply 2 to 4 fluid ounces per drain. Repeat as necessary. Recommend 1 to 2 applications per month.

### SURFACE TREATMENT

For use in odorous areas such as restrooms, janitorial closets, food preparation floor areas, garbage containers, dumpsters and surrounding areas. Apply 2 to 4 fluid ounces using a trigger sprayer to odorous areas. For large services, dilute 4 to 8 fluid ounces per gallon of water and apply with a mop, compressed air sprayer or through a power washer. Repeat as necessary.

To avoid or prevent slipping, deny entry to wet area until completely dry.
