Waste Lagoons: (i.e., poultry, swine and dairy operations; food processing plants). Initial: Apply Apply 2 gallons per surface acre of lagoon. Maintenance: Treat daily with one gallon per surface acre. Automated Application Systems are available through CXI. (972) 471-7775.
