### Product Information

Web Out kills spiders and helps prevent spider webs on surfaces that may support spider web attachment. This product can also be used as a contact pesticide to kill ants, crickets, mosquitoes, cockroaches and many other perimeter pest insects.

Web Out is a 25(b) FIFRA exempt product; therefore it has not been registered by the United States Environmental Protection Agency. Nisus Corporation represents that this product qualifies for exemption from registration under the Federal Insecticide, Fungicide, and Rodenticide Act. Web Out is biodegradable.

Web Out may be applied around vehicles and residential, institutional and commercial structures. Web Out can be applied to metal, wood, painted surfaces, brick, stucco, fiberglass, concrete, paneling and many other surfaces.

Web Out contains plant essential oils that are inherently fragrant. Limit interior applications to unoccupied or well ventilated areas such as, but not limited to: attics, basements, crawlspaces, sheds, outbuildings, greenhouses, garages or outdoor screened enclosures.

**Products containing essential oils can stain surfaces that can absorb oil, including, but not limited to, plastic, vinyl siding, concrete, bare wood and materials painted with fat or semi-gloss paint. Do not apply to these surfaces if staining is a concern.** Always test an inconspicuous area for colorfastness before use.

### Product Application

This product is ready to use; no dilution required. Shake or agitate before and during use. Spray a fine mist on the areas to be treated. One quart covers up to 200-300 square feet of surface area. If overspray is a concern, apply Web Out with a sponge or cobweb brush. If overspray occurs, clean surfaces with warm, soapy water. Reapplication may be necessary depending on climate and pest pressures.

*For spiders and spider webs:* Spray directly on spiders, webs and surrounding areas, then use a cobweb brush or broom to clean the area.

*User Precautions:* Eye protection and nitrile or latex gloves are recommended when applying this product. This product's fragrance will dissipate in a short time. Do not apply to human or animal food, food contact surfaces or food crops.

### First Aid:
